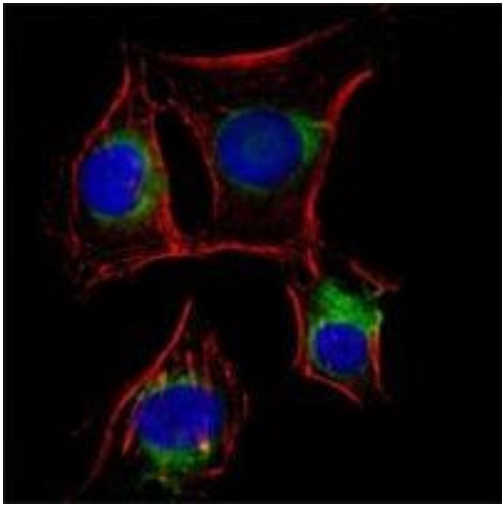
## Product Specific Information

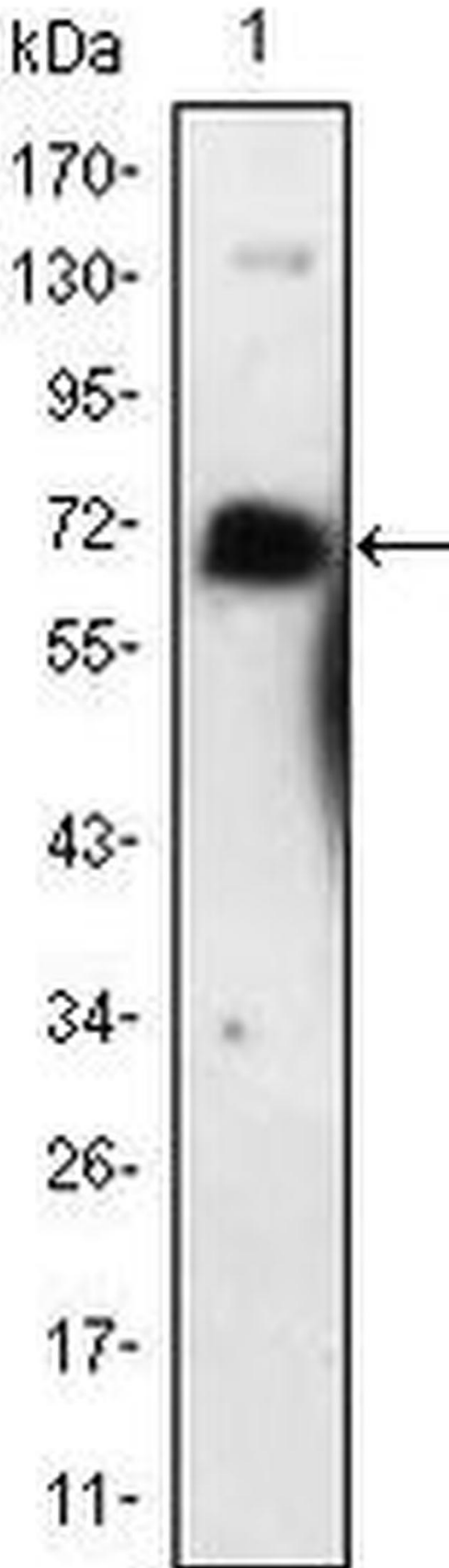


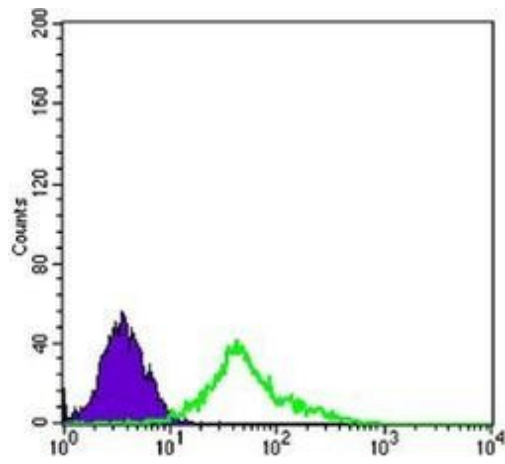
### NGFR Antibody (MA5-15574) in ICC/IF
